I have been involved in the hiring process which has added multiple new members to the news team, while also working collaboratively with Shé, our visual content executive to enhance inter-department communication between the news and visual teams by organising Observer's first joint team meetings.

I am proud of my efforts in streamlining the process of onboarding new reporters, by creating documents which outline what is needed to be done by new reporters when they join the organisation, as well as providing resources to further their skill development as reporters, such as source-finding, and contact creation.

As part of my responsibilities as a member of the board, I have helped negotiate with our Finance Executive Maddy the allocation and acquisition of funding to further the organisation, which has involved liaising with university staff and external parties.

Appendix C: Visual Content Executive Report – Shé Chani

During my time as Visual Content Executive, my team has commenced a long-term documentary project with ANU Rocketry, established a year-long partnership with the Interhall Arts Committee (IAC), received extra funding for our visual team ventures and re-established our social media structure. The documentary has expanded the team's skills around visual journalism as the production process has required a consistent understanding of important documentation areas, an awareness of interview opportunities and a foundational understanding of storytelling principles.

During the partnership with IAC, we've delivered a full livestream, social media coverage, and photographic coverage of their annual theatre sports event. We are also in the post-production process of a full recording of IAC's Big Night Out. This project required communication between the external production company, IAC, and ANU Observer. Balancing the coordination of these different stakeholders and the execution of the filming process expanded my abilities in time and project management. Applying for extra reserve funding helped sharpen my skills in pitching and budgeting. Receiving this funding will streamline our production process and familiarise our team with industry standard practice.

Finally, working closely with our social media manager to re-establish our social media structure has strengthened the visual brand of ANU Observer, and has seen positive engagement from the community. While improvements in the administrative side of the visual team (ie introducing a stronger weekly review process), and further improvements in production processes (ie the delivery of article graphics) could be established, the visual team has worked effectively up to this point with the resources they have.

Collaborating closely with our Editor-in-Chief, Ryan Bourke, and Editor, Rowey Worner-Butcher, we dedicated our weekend to ensuring the office space met the stipulations outlined in our tenancy agreement, particularly in anticipation of the landlord inspection conducted two months ago.

Looking ahead, I am committed to fostering greater cohesion among our news, podcast, and visual teams through enhanced social initiatives. Recognizing the limited interaction among these distinct teams, I aim to facilitate more inclusive social gatherings to nurture a sense of camaraderie and collaboration. A notable achievement this semester has been the establishment of monthly cross-team meetings, fostering deeper connections and a more cohesive organisational culture.

I have undergone governance training with the Australian Institute of Company Directors, and I strive to ensure that all of ANU Observer's financial practices are ethical and are being held to the highest governance standards.
